The ideal candidate will hold a State of Iowa Grade 2 or higher Water Treatment License and will have a minimum of one year of recent experience in equipment, machinery, or vehicle maintenance; however, we are willing to train the right candidate.

### **ESSENTIAL FUNCTIONS:**

- Performs general maintenance on process and test equipment, vehicles and machinery
- Construct and repair structures for buildings/grounds
- Collects and analyzes water samples
- Responds to after-hours emergencies
- Fills plant operation shifts as scheduled and in emergencies
- Operates, adjusts, and maintains treatment equipment
- Monitors the treatment process by performing lab analyses and evaluating lab test results
- Records data for reporting purposes
- Monitors weather, fire and security systems; acknowledges alarms and makes appropriate communication contacts in emergency situations through use of telephone and two-way radio system
- Controls and operates all pumps
- Loads and unloads materials and chemicals
- Participates in treatment plant safety meetings and maintains a safe working environment at all job

- Provides after-hours assistance to customers

**ESSENTIAL REQUIREMENTS:**

- Must be able to comply with shift schedules
- Successful completion of High School or GED
- Demonstrates good communication and mathematical skills
- Basic plumbing, electrical, and carpentry skills
- Ability to read and understand blueprints
- Basic knowledge of the use of hand tools
- Willingness to develop skills and obtain needed licenses
- Possession of a valid Iowa driver's license with a good driving record
- Able to obtain valid State of Iowa Grade II Water Plant Operator's Certificate within 39 months of appointment; training resources will be provided by MWW

**PREFERENCE WILL BE GIVEN to individuals with the following:**

- Minimum of two years of recent experience in water treatment plant operations
- Minimum of one year of recent experience in equipment, machinery, or vehicle maintenance
- Grade 1 or higher Iowa Water Treatment Plant Operator Certificate
- Post high school certificate or credit hours in the water treatment field

**ESSENTIAL PHYSICAL DEMANDS:**

- Occasionally handles up to 100 pounds and lifts 60 pounds
- Frequently climbs stairs and ladders and works on catwalks
- Ability to differentiate machine operational sounds
- Continuously walks, stands, squats, bends, kneels, twists or reaches overhead
- Occasionally handles high-pressure fire hoses
- Must be able to read gauges and distinguish colors
- Occasionally works in confined spaces

**ENVIRONMENTAL CONDITIONS:**

- Normally inside building
- Occasional exposure to adverse weather conditions
- Frequent exposure to machine noise
- Occasional exposure to hazardous chemicals
